WHEREAS, the Anchorage Assembly approved on January 11, 2000, Ordinance No. 2000-28 relating to capital construction/renewal projects/planning and design to be placed on the April 4, 2000 ballot; and

WHEREAS, the Anchorage Assembly approved AO No. 2000-39 (S-1) as amended relating to the FY 2000-2001 budget for the Anchorage School District on April 4, 2000, in accordance with Article VI, Section 6.05, of the Municipal Charter; and

WHEREAS, the qualified voters of the Municipality of Anchorage approved the education-related bond proposition that was on the April 4, 2000 Municipal Election ballot, Proposition 13; and

WHEREAS, the Anchorage School District's Debt Service Fund is being increased by \$2,724,720 and the taxes are being increased by \$2,059,135 to provide for the estimated six-month interest payment on the issuance of \$77.9 million authorized bonds approved by the qualified voters of the Municipality of Anchorage on April 4, 2000;
