WHEREAS, F. D.'s length of service extended beyond six mayors, initiating with  
Mayor John Asplund, and concluding with Mayor Rick Mystrom; and

WHEREAS, F. D. held acting positions as Supervisor and General Foreman  
performing exemplary in both of these capacities; and

WHEREAS, on September 19, 1977, he was promoted to Heavy Equipment  
Operator with the Street Maintenance Division and, because of his extensive experience  
and capabilities, on June 28, 1999, F.D. was promoted to Supervisor with the Street  
Maintenance Division; and

WHEREAS, during his tenure, he received several letters of commendation for his  
performance in his acting positions, for his excellent efforts during heavy storms, and for  
his work on the 12<sup>th</sup> and P Walkway; and

WHEREAS, on April 27, 2000, F. D. Schrecengost will retire from the Municipality  
with 29 years of service to the citizens of Anchorage.

NOW, THEREFORE, the Anchorage Assembly resolves that:


**F. D. SCHRECENGOST**
