A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE ENDORSING AN AGREEMENT BETWEEN MUNICIPAL LIGHT & POWER, THE IBEW, AND THE ADMINISTRATION REGARDING THE TRANSFER OF PENSION PLAN PARTICIPATION FOR CERTAIN EMPLOYEES FROM THE STATE OF ALASKA PUBLIC EMPLOYEE'S RETIREMENT SYSTEM (PERS) TO THE IBEW'S PENSION TRUST PLAN.

WHEREAS, the Municipality of Anchorage (hereinafter MOA) and the International Brotherhood of Electrical Workers (hereinafter IBEW) recognize that collective bargaining is the preferred method to achieve labor agreements; and

WHEREAS, the MOA and the IBEW have collectively met and agreed on the matter of six (6) "grandfathered" employees covered by the ML&P and IBEW collective bargaining agreement who were participants in PERS, and henceforth are members of the Alaska Electrical Pension Fund; and


WHEREAS, Anchorage Municipal Code 3.70.130, B, stipulates that Administrative Letters shall be presented to the Assembly for approval in the same manner as a municipal ordinance.

NOW, THEREFORE, the Anchorage Assembly hereby approves the agreement between the MOA and the IBEW regarding the transfer of the aforementioned employees to the Alaska Electrical Pension Trust.

**Letter of Agreement
