A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE PROVIDING FOR A REVISION OF THE ANCHORAGE SCHOOL DISTRICT BUDGET FOR FY 2000-2001 BY APPROPRIATING THE SUM OF FIVE MILLION DOLLARS (\$5,000,000) FROM THE ANCHORAGE SCHOOL DISTRICT FUND BALANCE TO THE ANCHORAGE SCHOOL DISTRICT BUDGET.
