A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY RECOGNIZING "BUCKLE UP AMERICA!" WEEK, MAY 22 - 29, 2000

WHEREAS, injuries are the leading cause of death for Alaskans between the ages of 1 and 44: and

WHEREAS, motor vehicle related injuries are by far the leading cause of injury death for Anchorage residents - being three times higher than the next leading cause; and

WHEREAS, in every state, it is the law that children be properly restrained with seat belts; and in every state except New Hampshire, it is the law that adults also wear seat belts; and

WHEREAS, even though such seat belt laws exist, over half of all children who die in motor vehicle accidents are unrestrained - typically, nearly half of these unbuckled children would be alive today if only they had been properly restrained; and

WHEREAS, dangerous driving behavior occurs daily on our streets, such as speeding, drinking and driving, and running red lights, and the best protection from such behavior is to buckleup; and

WHEREAS, May 22 - 29, 2000 is "Buckle Up America!" week, reminding all motor vehicle passengers - especially children - and drivers to "buckle up" at all times.

NOW, THEREFORE, the Anchorage Municipal Assembly resolves:

That the Assembly recognizes

"Buckle Up America!" Week May 22 - 29, 2000

and joins the Alaska Injury Prevention Center, and corporate, civic, and advocacy organizations in support of local law enforcement efforts to enforce child passenger safety and seat belt laws.
