11 A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY NAMING THE  
12 SOCCER FIELDS AT OBERG ROAD AND WEST HOMESTEAD ROAD IN PETERS  
13 CREEK THE "RUSSELL OBERG FIELD" IN RECOGNITION OF RUSSELL OBERG  
14 FOR HIS MAJOR CONTRIBUTIONS TO YOUTH RECREATION.

16 WHEREAS, AMC 3.97 establishes a means of recognizing and honoring  
17 persons who have substantially contributed to the Municipality of Anchorage by naming  
18 municipal-owned buildings, other fixed facilities, and public places after such persons; and  
19

20 WHEREAS, under AMC 3.97, this naming action may be initiated by a  
21 formal request of the Mayor; and  
22

23 WHEREAS, the Mayor desires to initiate such action to recognize and honor  
24 Russell Oberg; and  
25

26 WHEREAS, a Park Naming Committee held a public meeting to solicit and  
27 evaluate names, and  
28

29 WHEREAS, the Park Naming Committee and the Chugiak/Eagle River Parks  
30 & Recreation Board of Supervisors have recommended the soccer fields at Oberg Road and  
31 West Homestead Road in Peters Creek be named "Russell Oberg Field" in recognition of Mr.  
32 Oberg's major contributions to youth recreation; and

34 WHEREAS, though Russell Oberg never served as a public official or as a  
35 member of a Municipal board or commission, he prepared and maintained for many years  
36 approximately 13 acres of his property in Peters Creek; and offered his land as practice fields  
37 for youth sports, and other activities at no charge to the community; and

39 WHEREAS, the Assembly finds that Russell Oberg has made a generous  
40 contribution to the Municipality of Anchorage and officially naming "Russell Oberg Field"  
41 would provide a permanent recognition and honor for his unselfish support and contribution  
42 to healthy youth recreational activities.

44 NOW, THEREFORE, the Anchorage Assembly resolves:


1                   Section 1.     That the sports fields at Oberg Road and West Homestead  
2 Road in Peters Creek be named "Russell Oberg Field".

4                   Section 2.     That this resolution shall take effect immediately upon passage  
5 and approval by the Anchorage Assembly.
