A RESOLUTION ADOPTING THE 2000-2002 HOUSING AND COMMUNITY DEVELOPMENT CONSOLIDATED PLAN AND THE 2000 ACTION PLAN OF THE MUNICIPALITY OF ANCHORAGE, WHICH CONSTITUTES THE APPLICATION TO THE U. S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT, THE HOME INVESTMENT PARTNERSHIP GRANT AND THE EMERGENCY SHELTER GRANT.

WHEREAS, the Municipality of Anchorage has conducted extensive research and analysis to compile the 2000 Action Plan and the 2000-2002 Housing and Community Development Consolidated Plan, which is the basis upon which housing and community development needs of lower income residents and neighborhoods are addressed, and

WHEREAS, the 2000 Action Plan comprises the Municipality's application to the U. S. Department of Housing and Urban Development for the Community Development Block Grant, Home Investment Partnership Grant and Emergency Shelter Grant and identifies activities which the Municipality has elected to address the needs of lower income residents and neighborhoods, and

WHEREAS, the activities identified in the 2000 Annual Action Plan will, among other resources, utilize 2000 annual entitlements of Community Development Block Grant (CDBG), and Home Investment Partnership Grant (HOME), and Emergency Shelter Grant (ESG), and

WHEREAS, throughout the development of said application, Action Plan, and Consolidated Plan the Municipality of Anchorage actively sought participation of residents and representatives of lower income Anchorage neighborhoods, including community councils, and

WHEREAS, public testimony on said application, Action Plan, and Consolidated Plan was heard before the Housing & Neighborhood Development Commission on March 29, April 12, and May 10, 2000; and

WHEREAS, the Consolidated Plan and Action Plan will be endorsed by resolution of the Housing & Neighborhood Development Commission on June 12<sup>th</sup>, 2000.

NOW, THEREFORE, the Anchorage Assembly Resolves:

Section 1. The Assembly adopts the 2000 Annual Action Plan and the 2000-2002 Housing and Community Development Consolidated Plan as the general basis for a comprehensive approach to address the housing and community development needs of lower income residents and neighborhoods and the application for applicable federal grants.

Section 2. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.
