A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE NAMING THE SOFTBALL COMPLEX AT EAST 48TH AVENUE AND BRAGAW STREET THE "CHUCK ALBRECHT SOFTBALL COMPLEX" IN RECOGNITION OF CHUCK ALBRECHT FOR HIS MAJOR CONTRIBUTIONS TO THE ANCHORAGE SOFTBALL COMMUNITY.

WHEREAS, Chapter 3.97 of the Municipal Code establishes a means of recognizing and honoring persons who have substantially contributed to the Municipality of Anchorage by naming municipal-owned buildings, other fixed facilities, and public places after such persons; and

WHEREAS, the Parks and Recreation Commission advises the Mayor and the Assembly on selection of names of park or recreation facilities, and

WHEREAS, the Parks Naming Committee held a public meeting to solicit and evaluate names, and

WHEREAS, the Parks Naming Committee and the Anchorage Parks and Recreation Advisory Commission have recommended the softball complex at 48th Avenue and Bragaw Street be named the "Chuck Albrecht Softball Complex" in recognition of Mr. Albrecht's major contribution to the Anchorage softball community; and

WHEREAS, Charles P. "Chuck" Albrecht was well known in the softball community as an administrator, player, and official. He was a founder of the Anchorage Softball Association and served with that organization from 1973-98. Under his leadership, the ASA grew from 40 teams with 600 players to 300+ teams with over 4,500 players. In 1977, he persuaded the Women's Softball League to join the association, and in 1980, he helped to develop and incorporate the ASA coed softball program. In 1984, he was instrumental in the addition of volleyball to the association and hence, causing a name change to Anchorage Sports Association; and

WHEREAS, Charles P. "Chuck" Albrecht also played a major role in moving the softball program from the heavily used Park Strip fields to the Russian Jack and Cartee fields on Pine Street, thereby allowing more varied use of the park strip facilities. While a competitor on the field, he was well known for his sense of fair play, friendly attitude, and enthusiasm. Chuck was a friend to anyone who has played softball in Anchorage. The naming of this sports complex is a fitting tribute to Mr. Albrecht's vision of expanded opportunities for adult and youth recreation in our community.

NOW, THEREFORE, The Anchorage Assembly Resolves:

Section 1. That the softball complex located at E. 48th Avenue and Bragaw Street is named the "Chuck Albrecht Softball Complex."

Section 2. That this resolution shall take effect immediately upon passage and approval by the Anchorage Assembly.
