A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE PROVIDING FOR THE
APPROPRIATION OF SIX THOUSAND FIVE HUNDRED DOLLARS FROM DONATIONS TO THE
MISCELLANEOUS OPERATIONAL GRANT FUND (261) FOR THE PURCHASE OF LIBRARY
BOOKS.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum not to exceed SIX THOUSAND FIVE HUNDRED (\$6,500) in proceeds
from a donation from British Petroleum Exploration through Friends of the Library is hereby appropriated to
the Miscellaneous Operational Grant Fund (261) for the purchase of library books for the 2000 Wish List
Program.
