> WHEREAS, the U. S. Department of Education (Dept. of Education), conveyed a portion of the former Fort Richardson consisting of 118.0 +/- acres of land (herein the "Property") to the Greater Anchorage Area Borough (GAAB) and to the Municipality of Anchorage (Municipality); by succession of assets to the latter upon unification; and

WHEREAS, the conveyance of the Property was made subject to certain covenants and conditions. including a requirement that, for 30 years from the date of the Deed, the Property would be used solely and continuously for educational purposes; and

WHEREAS, the Assembly finds that the Road Access Easement and Revocable Use Permit between the Municipality and the Alaska Native Heritage Park (predecessor to the Alaska Native Heritage Center) is part of the Property; and

WHEREAS, the Municipality must obtain written consent to the Road Access Easement from the Dept. of Education, in the form attached as Exhibit A, to granting an easement to the Alaska Native Heritage Center (ANHC) across Municipal property at the Bartlett High School Site; and
