A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY RECOGNIZING AND HONORING  
BERNADINE W. RAISKUMS FOR HER 15 YEARS OF SERVICE WITH THE MUNICIPALITY OF  
ANCHORAGE

WHEREAS, Bernadine W. Raiskums began employment with the Internal Audit Department on April  
1, 1985 after having been on the Municipal audit team as a CPA with Arthur Young the previous three years;  
and

WHEREAS, within two years in Internal Audit, she earned her designation as a Certified Internal  
Auditor, was promoted to the position of Principal Auditor, and served on the Board of Directors of the  
Anchorage Chapter of the Institute of Internal Auditors; and

WHEREAS, in November 1988, Bernadine was promoted to the position of General and Enterprise  
Accounting Supervisor, subsequently earned designation as a Certified Government Financial Manager, and  
served as President of the Anchorage Chapter of the American Society of Women Accountants between  
1989-1990; and

WHEREAS, Bernadine represented the Municipality as one of 17 state and local governments  
participating in the Governmental Accounting Standards Board's field test of the Governmental Financial  
Reporting Model; and

WHEREAS, Bernadine was appointed Controller in 1998 where she led the Accounting, Accounts  
Payable, and Financial Information Systems sections through the PeopleSoft implementation; and

WHEREAS, Bernadine served as Acting Business Support Director/Controller for the Anchorage  
Parking Authority during the 1998 financial audit and represented the Municipality on the Board of Directors  
of the Alaska Government Finance Officers Association; and

WHEREAS, Bernadine's achievements throughout her tenure with the Municipality included her  
selection as a runner-up for the 1991 Municipal Employee of the Year and, in 1995, she received a Special  
Merit Award; and

WHEREAS, she also represented the Municipality on the UAA Accounting Department Advisory  
Board, received awards from the UAA College of Business and Public Policy for Outstanding Service  
Contributions by an Alumnus in 1991 and 1998, and is currently serving as an adjunct faculty member; and


WHEREAS, after 15 years of service, Bernadine will retire from the Municipality on June 30, 2000 to
