A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING SIX 1 HUNDRED THOUSAND DOLLARS (\$600,000) FROM WITHIN THE AREAWIDE 2 GENERAL CAPITAL IMPROVEMENT PROGRAM FUND (401) AND TWENTY FIVE 3 THOUSAND DOLLARS (\$25,000) AS A CONTRIBUTION FROM THE AREAWIDE 4 GENERAL CAPITAL IMPROVEMENT PROGRAM FUND (401) TO THE ANCHORAGE 5 ROADS AND DRAINAGE SERVICE AREA (ARDSA) CAPITAL IMPROVEMENT 6 PROGRAM FUND (441) IN SUPPORT OF THE MUNICIPAL FACILITIES MAJOR 7 8 MAINTENANCE AND UPGRADE PROGRAM

WHEREAS, on October 21, 1997 (AR 97-236, AM 845-97), the Anchorage
 Assembly passed a resolution establishing a Municipal Facilities Major Maintenance and
 Upgrade Program for municipally-owned general government facilities and appropriated
 \$2,528,000 from general government capital improvement program funds in support of
 the Municipal Facilities Major Maintenance and Upgrade Program; and

WHEREAS, on July 22, 1997 the Anchorage Assembly appropriated
\$972,000 of designated fund balance from various operating funds to corresponding
capital funds to provide local match funding for 1997 major maintenance and upgrade of
municipal facilities; and

WHEREAS, on September 21, 1999, the Anchorage Assembly passed a resolution authorizing application for matching capital grant funds through the Municipal Capital Project Matching Grant Program, which included a commitment to provide the local share required under AS 37.06.090; and

WHEREAS, insufficient funds are available to match a 2000 State Legislative grant to the Municipality of Anchorage under the Municipal Capital Project Matching Grant Program (AS 37.06) for Municipal Facility Upgrades, and

WHEREAS, the Municipality wishes to continue its pro-active program of funding major maintenance and facility upgrade work by using a combination of matching state grant funds and local dollars.

34 NOW, THEREFORE, THE ANCHORAGE ASSEMBLY HEREBY RESOLVES:

 36 Section 1. That the amount of Six Hundred Thousand Dollars (\$600,000 is
 37 hereby appropriated from within the Areawide General Capital Improvement Project Fund

(401) for the Municipal Facilities Major Maintenance and Upgrade Program benefiting
 facilities in the Areawide Service Area.

<u>Section 2</u>. That the amount of Twenty Five Thousand Dollars (\$25,000) is hereby appropriated as a contribution from the Areawide General Capital Improvement Project Fund (401) to the Anchorage Roads and Drainage Service Area Capital Improvement Fund (0441) for the Municipal Facilities Major Maintenance and Upgrade Program benefiting facilities in the Anchorage Roads and Drainage Service Area.

<u>Section 3</u>. That this resolution shall become effective immediately upon passage and approval by the Assembly.
