A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY
APPROPRIATING THE SUM OF THREE HUNDRED FIFTY THOUSAND, TWO
HUNDRED DOLLARS (\$350,200) FROM SEIZED AND FORFEITED MONIES
AWARDED FROM CRIMINAL NARCOTICS CASES BY THE U.S. DRUG
ENFORCEMENT AGENCY, TO THE POLICE INVESTIGATION FUND (257) FOR
USE BY THE ANCHORAGE POLICE DEPARTMENT.

THE ANCHORAGE MUNICIPAL ASSEMBLY RESOLVES:

Section 1. The sum of THREE HUNDRED FIFTY THOUSAND, TWO
HUNDRED (\$350,200) is appropriated to the Police Investigation Fund (257) from seized and
forfeited monies awarded from criminal narcotics cases by the U.S. Drug Enforcement Agency
and the State and Federal Courts to the Anchorage Police Department.

Section 2. This resolution shall take effect immediately upon passage and
approval.
