HONORING CHRIS KEMPER FOR HER VOLUNTEER EFFORTS

WHEREAS, Chris Kemper was the primary founder and organizer of the Anchorage Clay Arts Guild, composed of clay artists working together to advance pottery making skills; and

WHEREAS, to benefit Bean's Café, Chris spearheaded the "Empty Bowl Project", an activity in which the Anchorage Clay Arts Guild participated in a substantial effort to help our community's homeless; and

WHEREAS, as the first Chairperson of the "Empty Bowl Project", Chris' charismatic, caring and positive leadership not only united the Guild, but successfully recruited over 100 local companies to participate in the annual fundraising event held during Iditarod Days at the Fourth Avenue Theater; and

WHEREAS, since 1995, the "Empty Bowl Project" event has grown to over 2,000 attendees, netting over \$30,000 for Bean's Cafe; and

WHEREAS, given her endless commitment and unselfish energy as a volunteer, Chris was recently awarded the First Lady's Volunteer Award.

NOW, THEREFORE, the Anchorage Municipal Assembly resolves:

That the Assembly recognizes and honors

for her volunteer efforts in introducing and spearheading the "Empty Bowl Project"
