A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY SUPPORTING THE CHUGIAK DOG MUSHERS ASSOCIATION'S STATE RECREATIONAL TRAILS GRANT APPLICATION TO CONSTRUCT A BUILDING FOR THE ASSOCIATION IN BEACH LAKE PARK

WHEREAS, the Chugiak Dog Mushers Association is a non-profit organization formed to encourage participation in Alaska's state sport and promote its future; teach junior mushers the responsibilities of care, health and training of sled dogs; enhance appreciation of the mental and physical abilities of sled dogs; learn and practice good sportsmanship and teamwork; and create a place where mushers can meet; and

WHEREAS, the Association is applying for a State Recreational Trails Grant to build a clubhouse for the Association at the dog mushing trailhead in Beach Lake Park; and

WHEREAS, the Association is the only major dog club in Alaska without a clubhouse; and

WHEREAS, this proposed 24'x40' building will

Improve safety and comfort during races and other events;

Improve the Association's ability to sell food and souvenirs, thus helping to finance the Association's trail maintenance and improvement efforts;

Help the Association host educational events which combine classroom and trail activities; Provide a display area for Association memorabilia;

Provide needed meeting space for the community; and

WHEREAS, the Association has already built trails, a timing tower, and restroom facility in Beach Lake Park; and

WHEREAS, a "visitors center/staging area" for dog mushing was recommended for Beach Lake Park in the Municipality's 1984 Eagle River-Chugiak-Eklutna Park and Open Space Plan; and

WHEREAS, last year, the Eagle River-Chugiak Park and Recreational Service Area Board of Supervisors formally supported the Association's plans to construct this proposed building.

NOW, THEREFORE, the Anchorage Municipal Assembly resolves:

That the Assembly supports the Chugiak Dog Mushers Association's application for a State Recreational Trails Grant to construct a building for the Association in Beach Lake Park.
