Department for the Library Catalog Enhancement grant.



SUBJECT: Appropriation of a Grant from the State of Alaska for Library Catalog Enhancement (\$12,000) for the Library.

Cultural and Recreational Services has received notification that the Anchorage Municipal Library system has been awarded a \$12,000 grant by the State of Alaska, Department of Education, Division of Libraries. It is requested that this grant be appropriated to the State Categorical Grant Fund(231) for the purpose of funding Library Catalog Enhancement.

The Catalog Enhancement Grant provides catalog enrichment services to the residents of the State of Alaska to enhance search and retrieval capabilities by converting the bibliographic records for an estimated 14,000 fiction and biography titles held by the library system. These grant funds cover the period of July 1, 2000 through June 30, 2001.
