1 A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE ACCEPTING A SECTION  
2 5307 GRANT FROM THE FEDERAL TRANSIT ADMINISTRATION FOR \$1,608,800  
3 AND APPROPRIATING ONE MILLION FOUR HUNDRED THIRTY-SIX THOUSAND  
4 EIGHT HUNDRED DOLLARS (\$1,436,800) THEREFROM TO THE PUBLIC  
5 TRANSPORTATION CAPITAL IMPROVEMENT FUND (485) AND ONE HUNDRED  
6 SEVENTY-TWO THOUSAND DOLLARS (\$172,000) TO THE FEDERAL  
7 CATEGORICAL GRANTS FUND (241) AND A CONTRIBUTION OF FORTY THREE  
8 THOUSAND DOLLARS (\$43,000) FROM THE AREAWIDE GENERAL FUND (101) TO  
9 THE FEDERAL CATEGORICAL GRANTS FUND (241) FOR OPERATING AND  
10 CAPITAL ASSISTANCE TO THE PUBLIC TRANSPORTATION SYSTEM IN THE  
11 MUNICIPALITY OF ANCHORAGE

13 WHEREAS, the Municipality of Anchorage periodically applies for and receives  
14 Federal Transit Administration (FTA) grants for capital, operation and other purposes in  
15 connection with operation of its transit system,

16  
17 NOW, THEREFORE, the Anchorage Assembly resolves:

18  
19 Section 1 The Administration is authorized to accept a FTA Section 5307 grant.

20  
21 Section 2. That the sum of One Million Four Hundred Thirty-six Thousand Eight  
22 Hundred Dollars (\$1,436,800) is hereby accepted and appropriated from the Federal  
23 Transit Administration to the Public Transportation Capital Fund (485) to fund the  
24 purchase of Public Transportation Capital Items.

25  
26 Section 3. That the sum of One Hundred Seventy-two Thousand Dollars  
27 (\$172,000) from the Federal Transit Administration is hereby appropriated to the  
28 Federal Categorical Grants Fund (241) to co-fund a transportation skills assessment  
29 center and travel training program for people with disabilities and for senior citizens.

30  
31 Section 4. That the sum of Forty-three Thousand Dollars (\$43,000) is hereby  
32 appropriated as a contribution from the Areawide General Fund (101) to the Federal  
33 Categorical Grants Fund (241) to co-fund a transportation skills assessment center and  
34 travel training program for people with disabilities and for senior citizens.

35  
36 Section 5. This resolution shall take effect immediately upon passage and  
37 approval by the Municipal Assembly of Anchorage.
