A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY APPOINTING ALAN MUISE AS OMBUDSMAN FOR A TWO-YEAR TERM TO EXPIRE DECEMBER 31, 2002 AND DETERMINING ANNUAL SALARY

WHEREAS, the Home Rule Charter of the Municipality of Anchorage guarantees the citizens the right to the assistance of a municipal ombudsman in dealing with grievances and abuses; and

WHEREAS, the Charter further provides the office of the ombudsman be established in the legislative branch; and

WHEREAS, the Assembly has assigned functions and responsibilities to the office of ombudsman by adopting Section 2.60 of the Anchorage Municipal Code; and

WHEREAS, AMC Section 2.60 further provides the term of office for the ombudsman expires on December 31 of even-numbered years and that the Assembly determines appropriate compensation.

NOW, THEREFORE, BE IT RESOLVED by the Anchorage Municipal Assembly that Alan Muise is hereby appointed municipal ombudsman for a two-year term ending on December 31, 2002 and that he receive an annual salary of \$59,550 unless altered by the Assembly.
