A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY RECOGNIZING AND THANKING MEMBERS OF THE DUI PREVENTION TASK FORCE FOR THEIR TIME AND EFFORTS

WHEREAS, this past Summer, concerns were raised by citizens over the deaths and injuries resulting from incidents of drunk driving; and

WHEREAS, in response to these concerns, the Anchorage Assembly approved a resolution calling for the formation of a special citizens task force to review the adequacy of current ordinances, laws, and administrative practices relating to the deterrence and prevention of the offense of driving while intoxicated and related offenses; and

WHEREAS, the resulting DUI Prevention Task Force, with members appointed by the Mayor, began its work sessions in August 2000, and ultimately held ten full Task Force meetings, including one meeting dedicated solely to public testimony, and several subcommittee meetings covering current laws, courts, and alternative solutions; and

WHEREAS, on October 30, 2000, the Task Force completed its final report, and its recommendations and currently being reviewed by the Municipality and the Alaska State Legislature.
