WHEREAS, prior to the November 2000 General Election vote on Proposition 4 (10 mill tax cap), a statewide grass roots organization - Alaskans United Against The Cap - was formed to educate the public on why Proposition 4 should be defeated; and

WHEREAS, Alaskans United Against The Cap with the theme - "The More You Know, The More It's NO!:

Consisted of over 500 volunteers who logged nearly 3,000 hours statewide (only one temporary staff person was paid for the last three months of the campaign);

Included 50 speakers who engaged in over 200 debates, presentations, and radio/TV interviews:

Formally received 66 resolutions from specific groups ranging from the Alaska League of Women Voters, Alaska Library Association, and Alaska State Chamber of Commerce to 12 local governments and four native organizations;

Received more than 1,200 contributions; and

WHEREAS, given the efforts of Alaskans United Against The Cap, Proposition 4 was defeated by nearly 71% of voters on November 7, 2000 - failing in all 40 State House Districts and 444 of 451 precincts statewide.
