3 SUBDIVISION #7, LOCATED IN THE VICINITY OF ST. JOHANN LOOP AND VAIL

7 WHEREAS, Chapter 10.02(8) provides that any action to convey or lease or
8 authorizing the conveyance or lease of any interest in lands of the Municipality must
9 be by ordinance, but Chapter 17.13(e) excerpts from said requirement revocable
10 permits or licenses, rights-of-way and easements which the Assembly finds to be
11 without substantial value to the Municipality; and

13 WHEREAS, the Anchorage Water and Wastewater Utility recommends
14 release of its interest within a utility easement; and
15

16 WHEREAS, this disposal will eliminate the encroachment within AWWU's
17 water and sewer interest; and
18

19 WHEREAS, the Assembly finds that the municipal interest in real property to
20 be disposed of (via relinquishment) hereunder is without substantial value to the
21 Municipality.

23 NOW THEREFORE, the Assembly of Anchorage resolves:

25 Section 1. The Municipality may relinquish its interest within said utility
26 easement on the following described property:




30 Section 2. This resolution shall take effect upon passage and approval by the




