11 AN ORDINANCE SUBMITTING TO THE QUALIFIED VOTERS RESIDING IN THE  
12 MOUNTAIN PARK/ROBIN HILL LIMITED ROAD SERVICE AREA AT THE REGULAR  
13 MUNICIPAL ELECTION APRIL 3, 2001 A BALLOT PROPOSITION APPROVING THE  
14 CONTINUATION OF SAID LIMITED ROAD SERVICE AREA FOR AN ADDITIONAL  
15 PERIOD OF THREE YEARS AND AMENDING ANCHORAGE MUNICIPAL CODE  
16 SECTIONS 27.20.280 AND 27.30.360.

19  
20 WHEREAS the Mountain Park/Robin Hill Limited Road Service Area was created by  
21 Anchorage Ordinance 83-116 (Anchorage Municipal Code section 27.30.360); and  
22

23 WHEREAS a showing of interest in continuing said limited road service beyond  
24 December 31, 2001 has been made by persons residing in said limited road service area; now  
25 therefore,

28 **THE ANCHORAGE ASSEMBLY ORDAINS:**  
29

30 Section 1. That a ballot proposition in substantially the following form shall be submitted to  
31 the qualified voters residing in the Mountain Park/Robin Hill Limited Road Service Area at  
32 the regular Municipal election on April 3, 2001:

37 **CONTINUATION OF THE**  
38 **MOUNTAIN PARK/ROBIN HILL LIMITED ROAD SERVICE AREA**

40 Shall the existence of the Mountain Park/Robin Hill Limited Road Service area be  
41 continued for an additional period of three (3) years after December 31, 2001 until  
42 December 31, 2004?

2 Section 2. That Section 27.20.280 of the Anchorage Municipal Code is hereby amended  
3 to read as follows:  
4

5 Pursuant to section 27.10.050, there is established a board of supervisors to  
6 administer the Mountain Park/Robin Hill Limited Road Service Area. The board shall  
7 consist of six members appointed by the mayor and confirmed by the Assembly to  
8 administer the service area until the regular election of October, 1984, at which time  
9 the supervisors will be elected for staggered terms. At least one member shall reside in  
10 the Sun Valley Heights area. Initial terms of supervisors elected at the regular  
11 election of October, 1984 shall be selected by lot. [THE SERVICE AREA WILL  
12 EXPIRE ON DECEMBER 31, 2001, UNLESS IT IS EXTENDED BY VOTE IN THE  
13 AREA AFFECTED AT THE REGULAR ELECTION OF APRIL 2001.]


15 Section 3. That Section 27.30.360 of the Anchorage Municipal Code is hereby amended  
16 to read as follows:  
17

18 There is a limited road service area within the municipality known as the  
19 Mountain Park/Robin Hill Limited Road Service Area to provide limited road  
20 maintenance and repair to the area described on the map located in section 27.30.700.  
21


22 Limited road maintenance and repair within the service area shall commence  
23 on January 1, 1984, and shall end on December 31, [2001] 2004, unless the service area  
24 is extended by an affirmative vote of the service area [AFFECTED] at the regular  
25 election of April [2001] 2004. The mill rate shall not exceed 1.3 mills in any calendar  
26 year.  
27

28 Section 4. Except for Section 3, this ordinance shall become effective upon passage and  
29 approval. Section 3 and the proposition contained in Section 1 shall become effective  
30 upon certification of the regular election on the proposition called for by this ordinance,  
31 but only if that proposition is approved by a majority of the qualified voters voting on  
32 the proposition.

12   **SUBJECT:**           **Extension of Limited Road Service Areas**

15   The Lakehill, Mountain Park Estates, Mountain Park/Robin Hill, Rabbit Creek  
16   View/Rabbit Creek Heights, Raven Woods/Bubbling Brook, Rockhill, Skyranch  
17   Estates, Totem, Upper Grover, and Valli Vue Estates Limited Road Service  
18   Areas expire on December 31, 2001 unless continued by an affirmative vote in  
19   the area affected. Therefore, ten ordinances have been presented requesting  
20   the Assembly propose ballot questions to extend the life of these LRSA's.

21  
22   There will be no additional economic impact on the private or public sector.  
23

24   Approval of the ordinances will place the propositions on the ballot for a vote at  
25   the April 3, 2001 Regular Election.
