ORDINANCE NO. 2001- 15

AN ORDINANCE SUBMITTING TO THE QUALIFIED VOTERS RESIDING IN THE RABBIT CREEK VIEW AND RABBIT CREEK HEIGHTS LIMITED ROAD SERVICE AREA AT THE REGULAR MUNICIPAL ELECTION APRIL 3, 2001, A BALLOT PROPOSITION APPROVING THE CONTINUATION OF SAID LIMITED ROAD SERVICE AREA FOR AN ADDITIONAL PERIOD OF THREE YEARS AND AMENDING ANCHORAGE MUNICIPAL CODE SECTIONS 27.20.160 AND 27.30.240.

WHEREAS THE Rabbit Creek View and Rabbit Creek Heights Limited Road Service Area was created by Anchorage Ordinance 80-134; and

WHEREAS a showing of interest in continuing said limited road service beyond December 31, 2001 has been made by persons residing in said limited road service area; now therefore,

THE ANCHORAGE ASSEMBLY ORDAINS

**Section 1.** That a ballot proposition in substantially the following form shall be submitted to the qualified voters residing in the Rabbit Creek View and Rabbit Creek Heights Limited Road Service Area at the regular Municipal election on April 3, 2001:

Shall the existence of the Rabbit Creek View and Rabbit Creek Heights Limited Road Service area be continued for an additional period of three (3) years after December 31, 2001 until December 31, 2004?

2 Section 2. That Section 27.20.160 of the Anchorage Municipal Code is hereby amended to read as  
3 follows:


4 There is established a board of supervisors to administer, pursuant to section 27.10.050, the  
5 Rabbit Creek View and Rabbit Creek Heights Limited Road Service Area, consisting of three  
6 members who shall be elected for staggered terms of one, two and three years. Two members shall  
7 constitute a quorum. In the event of a vacancy, the mayor shall appoint a qualified area resident,  
8 with confirmation by the Assembly, to serve until the next regular election. [THE SERVICE AREA  
9 BOARD OF SUPERVISORS WILL EXPIRE ON DECEMBER 31, 2001, UNLESS THE  
10 SERVICE AREA IS EXTENDED BY AN AFFIRMATIVE VOTE IN THE AREA AFFECTED  
11 AT THE REGULAR ELECTION OF APRIL 2001.]

12  
13 Section 3. That Section 27.30.240 of the Anchorage Municipal Code is hereby amended to read as  
14 follows:



16 There is established a limited road service area within the Municipality of Anchorage known  
17 as the Rabbit Creek View and Rabbit Creek Heights Limited Road Service Area to provide for  
18 limited road maintenance and repair to the area described on the map located in section 27.30.700.  
19 Limited road maintenance and repair within the service area shall commence on January 1, 1981, and  
20 end on December 31, [2001] 2004, unless the service area is extended by an affirmative vote in the  
21 service area [AFFECTED] at the regular election of April [2001] 2004. The mill rate shall not  
22 exceed 2.5 mills in any calendar year.

23  
24 Section 4. Except for Section 3, this ordinance shall become effective upon passage and approval.  
25 Section 3 and the proposition contained in Section 1 shall become effective upon certification of the  
26 regular election on the proposition called for by this ordinance, but only if that proposition is  
27 approved by a majority of the qualified voters voting on the proposition.



15   The Lakehill, Mountain Park Estates, Mountain Park/Robin Hill, Rabbit Creek  
16   View/Rabbit Creek Heights, Raven Woods/Bubbling Brook, Rockhill, Skyranch  
17   Estates, Totem, Upper Grover, and Valli Vue Estates Limited Road Service  
18   Areas expire on December 31, 2001 unless continued by an affirmative vote in  
19   the area affected. Therefore, ten ordinances have been presented requesting  
20   the Assembly propose ballot questions to extend the life of these LRSA's.

22   There will be no additional economic impact on the private or public sector.

24   Approval of the ordinances will place the propositions on the ballot for a vote at  
25   the April 3, 2001 Regular Election.
