SECTION 2. That Section 27.30.310 of the Anchorage Municipal Code is hereby amended to read as follows:

There is a limited road service area within the Municipality of Anchorage known as the Valli Vue Estates Limited Road Service Area to provide limited road maintenance and repair to the area described on the map located in section 27.30.700.

Limited road maintenance and repair within the service area shall [COMMENCE ON DATE OF
CERTIFICATION OF ELECTION AND SHALL] end on December 31, [2001] 2004, unless the service
area is continued [EXTENDED] by an affirmative vote of the service area [AFFECTED] at the regular
election of April [2001] 2004. The mill rate shall not exceed 1.4 mill in any calendar year.

13 Section 3. Except for Section 2, this ordinance shall become effective upon passage and approval. Section 2 14 and the proposition contained in Section 1 shall become effective upon certification of the regular election on 15 the proposition called for by this ordinance, but only if that proposition is approved by a majority of the 16 qualified voters voting on the proposition.
