## THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1: That a proposition in substantially the following form be submitted before the qualified voters of Anchorage, Alaska at the April 3, 2001 Regular Election:

## PROPOSITION NO.

## LEVYING A TWO PERCENT (2%) GENERAL SALES TAX WITHIN THE MUNICIPALITY OF ANCHORAGE

Shall the Municipality of Anchorage be authorized to levy a two percent (2%) areawide general sales tax **on the price of all retail sales and rentals of goods,** subject to exemptions for food, medical prescriptions, and other exemptions the Assembly may prescribe, not to exceed \$250 for any single item purchased or rented?

The revenues collected from the general sales tax authorized by this proposition shall be substituted for property taxes.

Said tax shall be automatically repealed and cease to exist on May 15, 2004, unless continuation of said tax is approved by the voters.

Section 2: That upon approval of the ballot proposition by 60% of the qualified voters within the Municipality of Anchorage voting on this proposition at the April 3, 2001 Regular Election, the appropriate ordinance changes shall be prepared and implemented effective January 1, 2002.
