AN ORDINANCE OF THE ANCHORAGE ASSEMBLY AMENDING ANCHORAGE  
MUNICIPAL CODE SECTION 14.60.030 TO PROVIDE A CIVIL FINE SCHEDULE FOR  
SECTIONS 8.35.020 (SALE OF DRUG PARAPHERNALIA), 8.35.025 (POSSESSION OF  
DRUG PARAPHERNALIA) AND 8.35.030 (PENALTY; ADDITIONAL REMEDIES) AND  
PROVIDING FOR THE FORFEITURE OF DRUG PARAPHERNALIA.

THE ANCHORAGE ASSEMBLY ORDAINS:

**Section 1.** Anchorage Municipal Code section 14.60.030 is hereby amended to insert the  
following fines, currently provided for in AMC 8.35.025 and AMC 8.35.030: *(the remainder  
of the section is not affected and therefore not set out)*

18 a civil fine for AMC 8.35.030.A. Specifically, section 1 provides a civil fine schedule  
19 for AMC 8.35.020 (sale of drug paraphernalia) AMC 8.35.025 (possession of drug  
20 paraphernalia) and AMC 8.35.030 (penalty; additional remedies). The ordinance also  
21 provides for the forfeiture of the drug paraphernalia.
