



1 AN ORDINANCE AMENDING ANCHORAGE MUNICIPAL ORDINANCE AO 2001-80 BY
2 CHANGING THE EFFECTIVE DATE ON THE PROHIBITION OF POLE SIGNS FOR LARGE
3 RETAIL ESTABLISHMENTS.

6 WHEREAS, AO 2001-80 added a new section to Anchorage Municipal Code Title 21, which reads in part
7 as follows:

9 **21.50.320 Public Hearing Site Plan Review – large retail establishment.**

10
11 M. *Exterior signs.* Pole signs, rotating signs, and flashing signs shall be prohibited.

12
13 WHEREAS, AO 2001-80, including the sign prohibition, was effective immediately upon its passage and
14 approval on May 8, 2001; and

15
16 WHEREAS, the application of the prohibition on certain signs may unduly impact plans, contracts and
17 commitments already made by local businesses; now therefore,

18
19 **THE ANCHORAGE ASSEMBLY ORDAINS:**

20
21 **Section 1.** The prohibition on certain types of signs in Anchorage Municipal Code subsection 21.50.320M.
22 shall not be effective until June 1, 2002. AO 2001-80 is hereby amended consistent with the intent of this
23 section.

25 **Section 2.** This ordinance shall become effective immediately upon its passage and approval by the
26 Assembly.
