

32	on or before May 8, 2001 including those under construction as of that date, or

34	b. to govern, apply to, prohibit or otherwise restrict the repair, maintenance,						
35	expansion, modification, or improvement of pole signs, rotating signs, or flashing						
36	signs existing in large retail establishments on or before May 8, 2001 unless						
37	made applicable as part of a limited site plan required under AMC 21.55.130(A)						
38	for the expansion, reconstruction, renovation, or remodeling of the exterior						
39	portion(s) of an existing large retail establishment commenced after May 8, 2001
