of the following as the remedy for failure to complete community  
work service as ordered:

a Conversion of unsatisfied community work service hours to a  
fine at the rate of \$75.00 [\$50.00] for every eight hours or

**H.**      **Administrative fees.**

**1. Program monitoring.** Persons assigned to a treatment program as  
part of sentencing shall be assessed an administrative fee of \$50  
for the costs of file maintenance, supervision, and reporting.

**2. Noncompliance.** Persons who violate or fail to comply with the  
terms of probation, fail to comply with court-ordered monitoring
