

7 THE ANCHORAGE ASSEMBLY ORDAINS:

9 Section 1. Pursuant to Anchorage Municipal Code Section 4.05.150, the Mountain View
10 Community Recreation Center Advisory Commission shall be and is hereby continued and
11 reestablished as set forth in Anchorage Municipal Code Section 4.60.08522 for an additional period
12 of three (3) years from and after September 15, 2001. During the period of time from and after
13 September 15, 2001 until the effective date of this ordinance, all actions of the Mountain View
14 Community Recreation Center Advisory Commission, all appointments thereto and all unexpired
15 terms of its members shall continue to be and constitute the actions of, appointments to and the
16 unexpired terms of its members, as the case may be, as if it had not been terminated by operation
17 of law.



19 Section 2. Nothing in this ordinance shall be taken as or constitute any approval, ratification,
20 implementation of, or ruling or action by the Anchorage Municipal Assembly on any action of the
21 Mountain View Community Recreation Center Advisory Commission.


Subject: AO 2001-156; Continuing/Reestablishing the Mountain View Community Recreation Center Advisory Commission.

Among those listed was the referenced body and whose existence is scheduled to expire September 15, 2001. AMC 4.05.150 requires a public hearing at which the board or commission must demonstrate a public need for its continued existence. The Assembly may continue, reestablish or permit the board or commission to terminate.


