AN ORDINANCE OF THE ANCHORAGE MUNICIPAL ASSEMBLY CONTINUING OR REESTABLISHING THE ANCHORAGE PORT COMMISSION, ANCHORAGE VETERANS AFFAIRS COMMISSION, ANCHORAGE WATER & WASTEWATER UTILITIES COMMISSION, ARTS ADVISORY COMMISSION, BIDDING REVIEW BOARD, BOARD OF ETHICS, BUDGET ADVISORY COMMISSION, ELECTION COMMISSION, EMERGENCY MEDICAL SERVICE BOARD, EMPLOYEE RELATIONS BOARD, GEOTECHNICAL ADVISORY COMMISSION, HISTORICAL & FINE ARTS COMMISSION, LIBRARY ADVISORY BOARD, MUNICIPAL LIGHT & POWER COMMISSION, PARKS & RECREATION COMMISSION, HUMAN RESOURCES ADVISORY BOARD, PLATTING BOARD, PUBLIC FACILITIES ADVISORY COMMISSION, PUBLIC TRANSIT ADVISORY BOARD, SCHOOL BUDGET ADVISORY COMMISSION, SENIOR CITIZENS ADVISORY COMMISSION, SISTER CITIES COMMISSION, TRANSPORTATION COMMISSION AND ZONING BOARD EXAMINERS & APPEALS PURSUANT TO ANCHORAGE MUNICIPAL CODE AND EXTENDING THE TIME OF EXPIRATION FOR THE SOLID WASTE COMMISSION AND MUNICIPAL WOMEN'S COMMISSION.

THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1. Pursuant to Anchorage Municipal Code Section 4.05.150, the Anchorage Veterans Affairs Commission shall be and is hereby continued and reestablished as set forth in Anchorage Municipal Code Section 4.60.220 for an additional period of three (3) years from and after January 17, 2002. During the period of time from and after January 17, 2002 until the effective date of this ordinance, all actions of the Anchorage Veterans Affairs Commission, all appointments thereto and all unexpired terms of its members shall continue to be and constitute the actions of, appointments to and the unexpired terms of its members, as the case may be, as if it had not been terminated by operation of law.

Section 2. Pursuant to Anchorage Municipal Code Section 4.05.150, the following boards and commissions shall be and are hereby continued and reestablished as set forth in the Anchorage Municipal Code sections shown opposite each board or commission for an additional period of three (3) years from and after January 20, 2002. During the period of time from and after January 20, 2002 until the effective date of this ordinance, all actions of the boards or commissions, all appointments thereto and all unexpired terms of their members shall continue to be and constitute the actions of, appointments to and the unexpired terms of their members, as the case may be, as if the boards or commissions had not been terminated by operation of law.
