Those violations include allowing underage persons to enter and remain on the premises, allowing underage persons to purchase and consume alcohol, failing to control and police the parking area to prevent fights, failing to ensure employees have the required TAMS card, and serving alcohol to minors; and

WHEREAS under AS 04.11.480(c) the local governing body of the Municipality of Anchorage may recommend that a license be renewed with conditions imposed by the State of Alaska Alcoholic Beverage Control Board; and

WHEREAS, under state law, conditions recommended by a local governing body on the renewal of a beverage dispensary license shall be imposed by the Alcoholic Beverage Control Board unless the board finds the conditions are arbitrary, capricious, or unreasonable; and

WHEREAS, the licensee has agreed to apply within 6 months for an amendment to its conditional use permit to provide exterior lighting and landscaping.

- A) All employees shall submit to retraining in an approved alcohol server course and submit proof of such retraining to the city clerk within thirty (30) days.
- B) Alcohol service shall cease thirty (30) minutes prior to closing.
- C) Thirty (30) minutes before the time the restaurant designation permit is no longer in effect by its express terms, the licensees shall check all identifications of all patrons who appear to be less than thirty (30) years of age who are on the premises and shall require those under the age of twenty-one (21) years who are unaccompanied minors as defined by title 4, to leave the premises prior to the time the restaurant designation permit is no longer in effect.
- D) At any time when Karoke or other entertainment is offered, the Licensee shall have on duty at the door at least one person who is trained in an approved alcohol server course to check identification and the condition of any person seeking to come on the licensed premises.
- E) The Licensee shall keep a log of all incidents on the licensed premises and make such log available to officers of the Anchorage Police Department and the Alcoholic Beverage Control Board upon request.
- F) The Assembly shall review the record of this Licensed establishment with a view to a possible protest of continued operations as provided in AS 04.11.480(a) on or before January 31, 2001 even though this license will not be considered for renewal again for another two (2) years under the biennial licensing practices of the ABC Board.

# 10.50.010 Closing hours for licensed premises.

A. Premises licensed under AS 4.11.080 for the service and consumption of alcoholic beverages shall be closed for the sale, service and consumption of alcoholic beverages between the hours of 2:30 a.m. and 10:00 a.m. Monday through Friday, and between the hours of 3:00 a.m. and 10:00 a.m. on Saturday or Sunday or on a legal holiday recognized by the state under AS 44.12.010.

B. All other retail premises licensed under AS 4.11.080 shall be closed for the sale of alcoholic beverages between the hours of 1:00 a.m. and 10:00 a.m. Monday through Friday, and between the hours of 2:00 a.m. and 10:00 a.m. on Saturday, and between the hours of 2:00 a.m. and noon on Sunday.

(CAC 6.08.010; AO No. 81-35(S); AO No. 81-197)

#### 10.50.015 Prohibited acts.

### It is unlawful:

- A. For a person to barter or sell alcoholic beverages in a business premises that is not licensed by the state alcoholic beverage control board.
- B. For a licensee or his employee or agent to permit a person to drink intoxicating liquor on licensed premises not classified for sale and consumption of hard or distilled liquor by the board.
- C. For a licensee or his employee or agent to sell, attempt to sell, furnish, barter or permit to be consumed alcoholic beverages in any premises licensed under AS 4.11.080 for the service and consumption of alcoholic beverages between the hours of 2:30 a.m. and 10:00 a.m. Monday through Friday, or between the hours of 3:00 a.m. and 10:00 a.m. on Saturday or Sunday or on a legal holiday recognized by the state under AS 44.12.010.
- D. For a licensee, his employee, agent or any person in licensed premises to sell, attempt to sell, furnish, barter or permit to be consumed alcoholic beverages in any other retail premises licensed under AS

- 4.21.010 between the hours of 1:00 a.m. and 10:00 a.m. each Monday through Friday, or between the hours of 2:00 a.m. and 10:00 a.m. on Saturday, or between the hours of 2:00 a.m. and noon on Sunday.
- E. For a licensee, his employee, agent or any person in licensed premises to give, barter or sell alcoholic beverages to any person who, within the normal powers of observation, appears to be intoxicated. For the purposes of this section, a person appears to be intoxicated when he exhibits any symptom that indicates substantial loss of control of physical or mental facilities, including but not limited to bloodshot eyes, slurred speech, clumsiness, drowsiness, heavy odor of alcoholic beverages or undue or abnormal excitation or suppression of the passions or feelings.
- F. For a licensee, his employee, agent or any person in licensed premises to give, barter or sell alcoholic beverages to a person under 21 years of age.
- For a person under the age of 21 years to enter or remain upon licensed premises unless he is accompanied by his parent, guardian or spouse who has attained the age of 21 years. However, a person 18 years of age or older may enter and remain upon licensed premises in the course of his employment as a musician, entertainer or busboy. In addition, a person under the age of 21 years may enter and remain upon licensed premises also recognized as a restaurant for the purpose of dining or dancing if accompanied by his parent or guardian, or by the parent or guardian of any other minor also present. or by any other adult with the consent of the minor's parents or guardian.
- H. For a person under 21 years of age to solicit the purchase, to attempt to purchase or to possess alcoholic beverages.
- I. For a person under 21 years of age to enter a licensed premises and offer or present to a licensee or his employee or agent or a law enforcement officer a doc-
