9 A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY  
10 APPROPRIATING THE SUM OF FIVE HUNDRED SIX THOUSAND ONE  
11 HUNDRED FOUR DOLLARS (\$506,104) FROM THE U.S. DEPARTMENT OF  
12 JUSTICE, OFFICE OF JUSTICE PROGRAMS, LOCAL LAW ENFORCEMENT  
13 BLOCK GRANT AND FIFTY SIX THOUSAND TWO HUNDRED THIRTY FOUR  
14 DOLLARS (\$56,234) AS A CONTRIBUTION FROM THE 2001 ANCHORAGE  
15 METROPOLITAN POLICE SERVICE AREA OPERATING BUDGET FUND (151),  
16 ANCHORAGE POLICE DEPARTMENT, TO THE FEDERAL CATEGORICAL  
17 GRANTS FUND (241) FOR THE PURPOSE OF UNDERWRITING PROJECTS TO  
18 REDUCE CRIME AND IMPROVE PUBLIC SAFETY.

21 **THE ANCHORAGE MUNICIPAL ASSEMBLY RESOLVES**  
22

23 Section 1. That the sum of FIVE HUNDRED SIX THOUSAND ONE  
24 HUNDRED FOUR DOLLARS (\$506,104), is appropriated from the U.S.  
25 Department of Justice, Office of Justice Programs, Local Law Enforcement Block  
26 Grant (LLEBG) Program to the Federal Categorical Grants Fund (241),  
27 Anchorage Police Department for underwriting projects to reduce crime and  
28 improve public safety.

30 Section 2. That the sum of FIFTY SIX THOUSAND TWO HUNDRED THIRTY  
31 FOUR DOLLARS (\$56,234) is appropriated as a match from the Anchorage  
32 Metropolitan Police Service Area Fund (151) to the Federal Categorical Grant  
33 Fund (241) for the purpose of underwriting projects to reduce crime and improve  
34 public safety.

36 Section 3. This resolution shall take effect immediately upon passage and  
37 approval.
