THE ANCHORAGE ASSEMBLY RESOLVES:


Section 1: That the 2001 General Government Operating budget is revised by

Subject: **REVISING THE 2001 GENERAL GOVERNMENT OPERATING BUDGET BY APPROPRIATING \$5,000 FROM THE ANCHORAGE PARKS AND RECREATION SERVICE AREA FUND (161) BALANCE TO THE CULTURAL AND RECREATIONAL SERVICES DEPARTMENT TO PROVIDE FUNDING FOR TRAIL SIGNAGE**

During the 2001 budget process, \$5,000 was appropriated to provide funding for trail signage; the funding was, ultimately, vetoed and not overridden. Providing funds for the placement of signs on our trails is not only courtesy to joggers but, it is also a safety issue. Currently, joggers along our trail system have expressed the need for adequate signage, and are very concerned for their safety. For example, if a jogger is being followed by a stranger, a directional sign would assist in quickly relocating to a more populated area.

The attached resolution, if approved, will not provide all of the needed signs, but would be a great start toward this effort. It is estimated that 40+ signs could be installed using the requested \$5,000. The funding information follows:
