1 A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING OF
2 ONE HUNDRED EIGHTY-TWO THOUSAND THREE HUNDRED EIGHTY TWO
3 DOLLARS (\$182,382) FROM THE HERITAGE LAND BANK FUND (221) TO THE
4 HERITAGE LAND BANK CAPITAL IMPROVEMENT PROGRAM FUND (421) FOR
5 APPROVED HLB CAPITAL IMPROVEMENT PROGRAM PROJECTS

8 WHEREAS, the 2001 Capital Improvement Budget (CIB) was approved
9 November 8, 2000 by the Anchorage Assembly (AO 2000-146); and,

12 WHEREAS, the Approved 2001 CIB includes \$322,000 for Heritage Land Bank
13 (HLB) capital projects; and,

16 WHEREAS, \$139,618 is available in the HLB Capital Fund (421) from projects
17 that were completed under budget; and,

20 WHEREAS, an additional amount of \$182,382 is needed from the HLB General
21 Fund (221) to complete funding for 2001 HLB CIP projects; and

23 WHEREAS, the December 31, 2000 unaudited Undesignated Fund Balance of
24 the Heritage Land Bank Fund is \$3,205,055;

27 NOW THEREFORE, THE ANCHORAGE ASSEMBLY HEREBY RESOLVES

29 Section 1. That the sum of ONE HUNDRED EIGHTY-TWO THOUSAND
30 THREE HUNDRED EIGHTY TWO DOLLARS (\$182,382) is appropriated from the
31 Heritage Land Bank General Fund (221) to the Heritage Land Bank Capital Fund (421)
32 for HLB Capital Improvement Program projects.

34 Section 2. That the sum of ONE HUNDRED THIRTY-NINE THOUSAND SIX
35 HUNDRED EIGHTEEN DOLLARS (\$139,618) is reallocated from completed CIP
36 projects to fund Heritage Land Bank projects in the 2001 Approved Capital
37 Improvement Budget.

39 Section 3. This resolution shall take effect immediately upon approval by the
40 Assembly.
