**A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY URGING THE ANCHORAGE
PARKING AUTHORITY TO CONTINUE ALLOWING USE OF THE CITY-OWNED PARKING LOT
ON THIRD AVENUE BETWEEN C AND E STREETS FOR FUR RENDEZVOUS ACTIVITIES.**

WHEREAS, Fur Rendezvous - or "Rondy" - is Anchorage's annual winter festival and a major attraction and celebration for residents and tourists each February; and

WHEREAS, since 1935, the core of "Rondy" activities has been located in downtown Anchorage, specifically the carnival rides, food stands and Eskimo blanket toss which have been located in the city-owned parking lot on Third Avenue between C and E Streets; and

WHEREAS, the Anchorage Parking Authority may no longer lease the Third Avenue parking lot to "Rondy" organizers due to loss of parking revenues during the festival; and

WHEREAS, optional locations have been reviewed, but are either too small, too far from downtown or have restrictions; and

WHEREAS, though some "Rondy" activities have already been displaced outside of the downtown area, and others are being threatened by future development in the Ship Creek area, the core of "Rondy" needs to continue in the downtown area for an accessible and viable festival.

NOW, THEREFORE, the Anchorage Assembly resolves:


Section 1: That the Assembly urges the Anchorage Parking Authority to work out a reasonable lease agreement with Fur Rendezvous organizers that will allow continued use of the city-owned parking lot on Third Avenue between C and E Streets.

Section 2: That, upon passage and approval, a copy of this resolution be forwarded to the Anchorage Parking Authority.
