A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING ONE MILLION THREE HUNDRED SEVENTY-NINE THOUSAND THREE HUNDRED FORTY DOLLARS (\$1,379,340) OF 2001 TAX REVENUES FROM THE CHUGIAK, BIRCHWOOD, EAGLE RIVER RURAL ROAD SERVICE AREA (CBERRRSA) FUND (119) TO THE CBERRRSA CAPITAL IMPROVEMENT PROGRAM MILL LEVY FUND (419) AND APPROPRIATE THIRTY THOUSAND TWENTY THREE DOLLARS (\$30,023) OF 2000 CAPITAL IMPROVEMENT PROGRAM MILL LEVY REVENUES CONTRIBUTED AS PART OF 2000 FIRST QUARTER BUDGET REVISIONS FOR ROAD AND DRAINAGE CAPITAL IMPROVEMENT PROJECTS

WHEREAS, the Department of Public Works is authorized one Mill from the CBERRRSA Mill Levy for Road and Drainage Capital Improvement Projects in the CBERRRSA, and

WHEREAS, ONE MILLION THREE HUNDRED SEVENTY-NINE THOUSAND THREE HUNDRED FORTY DOLLARS (\$1,379,340) has been projected in the 2001 General Government Operating Budget for the CBERRRSA Mill Levy for Road Drainage and Capital Improvement Projects, and

WHEREAS, THIRTY THOUSAND TWENTY THREE DOLLARS (\$30,023) was contributed from CBERRSA Fund (119) as part of the 2000 first quarter budget revision to the CBERRSA Capital Improvement Program Mill Levy Fund (419) in excess of the original amount budgeted, and

WHEREAS, at no time shall transfers of funds from the CBERRRSA Mill Levy Fund (119) to the CBERRRSA Capital Improvement Program Mill Levy Fund (419) exceed the pro-rata share of the collected Mill Levy revenue designated for the CBERRRSA Capital Improvement Program.

THE ANCHORAGE ASSEMBLY RESOLVES.

Section 1. That ONE MILLION THREE HUNDRED SEVENTY-NINE THOUSAND THREE HUNDRED FORTY DOLLARS (\$1,379,340) of revenues from the CBERRRSA Mill Levy Fund (119) is appropriated to the CBERRRSA Capital Improvement Program Mill Levy Fund (419).

Section 3. That transfer of cash from the CBERRRSA Mill Levy Fund (119) at no time shall exceed the pro-rata share of the collected Mill Levy designated for the CBERRRSA Capital Improvement Program.

Section 4. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

Appropriation Of 2001 Chugiak, Birchwood, Eagle River Rural Road Service Area (CBERRRSA) Capital Mill Levy Revenues and 2000 First Quarter Revised Capital Mill Levy Revenues For The CBERRRSA Capital

Improvement Program

The attached Resolution, AR 2001-94, appropriates revenues from the 2001 CBERRRSA Mill Levy Fund (119) for road and drainage improvements in the CBERRRSA. The CBERRRSA Capital Improvement Mill Levy was approved by voters on October 1, 1991. The total 2001 CBERRRSA Capital Improvement Mill Levy is budgeted to be \$1,379,340. An additional \$30,023 of 2000 Capital Improvement Mill Levy Revenue was contributed to the CBERRRSA CIP Fund (119) as a first quarter supplemental budget revision in 2000. These additional funds were not appropriated for expenditure in the Capital Improvements Fund (419) in 2000.

As the CBERRSA Mill Levy is collected, that portion designated for CBERRSA Capital Improvement Projects will be transferred to the CBERRSA Capital Improvement Mill Levy Fund (0419).

The CBERRRSA Board is aware of this appropriation and recommends that the Assembly approve it.
