The Child/Adult Care Program in the Department of Health & Human Services due to the State Grant, has extended its services this year. In addition to its current responsibility for licensing child care centers, and serving as the coordination office for agencies required to approve child care, it will be responsible for all licensing and registration for child care homes. The State Department of Health and Social Services has funded a portion of these services since 1989, providing \$492,778 for FY01.
