After a long planning process, drawings and estimates were prepared in 1992, and the funding was appropriated through the Mental Health Trust Fund. After several changes to the plan due to costs, design, and other issues, the project went to bid in 1999. Unfortunately, the bids were well over the amount available for construction, and the project had to be rebid. After the contract was awarded and construction started, there is little left to purchase furnishings and equipment necessary to run the program in the new facility.

The attached resolution, if approved, will provide the necessary funds to purchase the needed furnishings to complement the Center and assure occupancy as scheduled. The funding information follows:
