**AREOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY RESCINDING AM NO.  
319-2001 APPROVING FUNDING AND THE PROFESSIONAL SERVICES AGREEMENT  
WITH THE ANCHORAGE CONVENTION AND VISITORS BUREAU (ACVB)**

WHEREAS, on March 27, 2001, AM 319-2001 was approved which funded a professional services agreement between the ACVB and the Municipality of Anchorage; and

WHEREAS, notice of reconsideration was given and the memorandum was carried over to the meeting of April 17, 2001; and

WHEREAS, due to lack of time and an Anchorage Municipal Code requirement relating to items noticed for reconsideration, the AM was not reconsidered and, subsequently, died; and

WHEREAS, a signed contract between the MOA and the ACVB is currently nonexistent.

NOW, THEREFORE, the Anchorage Assembly resolves:

**Section 1:** That AM No. 319-2001 approving funding and the professional services agreement with the Anchorage Convention and Visitors Bureau is, hereby, rescinded in its entirety.

**Section 2:** That this resolution is effective immediately upon passage and approval.
