A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY RECOGNIZING AND HONORING  
DONALD E. BENNETT FOR HIS THIRTY YEARS OF SERVICE WITH THE MUNICIPALITY OF

WHEREAS, Donald E. Bennett joined the Greater Anchorage Area Borough in 1971 as an  
Engineering Aide in the Sewer Utility Department; and

WHEREAS, during his tenure, he worked in various divisions within the Department including  
Engineering Design, Utility Planning, and Technical Services; and

WHEREAS, because of his planning efforts, the Utility was able to embark upon a construction  
schedule that doubled their water capacity and increased the wastewater capacity by 70%; and

WHEREAS, due to Don's good work, AWWU have received major grants from State and Federal  
sources, as well as strong community support on local bond issues; and

WHEREAS, during his service, his excellent work relations with developers and contractors  
consistently insured quality growth in an orderly manner; and

WHEREAS, Don was also instrumental in implementing and completing a number of projects, i.e.  
Girdwood Fire Station, Demolition of Hollywood Vista Apartments, Egan Center Skybridge, Eagle River Fire  
Station, the New Greenhouse at Russian Jack, and Chugiak Senior Center Adult Day Care Center; and

WHEREAS, in 1991, Don left AWWU to work for Property & Facility Management as a Project  
Manager; and


WHEREAS, after 30 years of service as a dedicated public servant and achieving the highest  
standards of integrity and professional competence, Don will retire from the Municipality of Anchorage on April  
27, 2001.
