WHEREAS, during his tenure Joe oversaw, directed, and managed the completion of many projects, such as the Hill Building transformation, Mountain View Community Center, Hollywood Vista demolition, Historic City Hall renovation, Dempsey II Ice Rink, Egan Skybridge, and Girdwood Fire Station; and

WHEREAS, Joe's many other accomplishments included numerous other undertakings in the areas of facility maintenance, fleet services, and project development; and

WHEREAS, on April 27, 2001, Joseph A. Beauchamp will retire from the Municipality of Anchorage.
