**A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY SUPPORTING
THE USE OF INTERIM BOARD AND COMMISSION MEMBERS TO FILL
VACANCIES WHICH HAVE BEEN OPEN FOR MORE THAN SIXTY DAYS.**

WHEREAS, Municipal boards and commissions - whether advisory, regulatory, appellate, or quasi-judicial - play a vital role in providing an efficient and responsible government for our community; and

WHEREAS, by Municipal Charter and Code, members of boards and commissions shall be appointed by the Mayor and confirmed by the Assembly; and

WHEREAS, the effectiveness of boards and commissions can be hampered by member vacancies, such as the current vacancies on the Planning & Zoning Commission; and

WHEREAS, the Assembly finds that 60 days is sufficient time for Mayoral appointments to board and commission vacancies; and if such appointments are not made within 60 days, interim members, as appointed and approved by the Assembly, should be assigned to fill the vacancies until permanent appointments are made by the Mayor.

NOW, THEREFORE, the Anchorage Municipal Assembly resolves:

Section 1: That the Assembly supports the use of interim board and commission members to fill vacancies which have been open for more than 60 days.

Section 2: That the Assembly directs the Municipal Attorney to draft the necessary Charter and Code changes to allow for Assembly appointment and approval of interim board and commission members to fill vacancies which have been open for more than 60 days, until permanent appointments are made by the Mayor and confirmed by the Assembly.

Section 3: That this resolution is effective upon passage and approval.
