A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY URGING THE ALASKA LEGISLATURE TO ALLOW THE PUBLIC TO USE ITS DOWNTOWN PARKING LOT FOR EVENING AND WEEKEND PARKING.

WHEREAS, continued development of downtown Anchorage has made public parking scarce and expensive; and

WHEREAS, the Municipality of Anchorage allows the public to use its City Hall parking lot for evening and weekend parking; and

WHEREAS, the Alaska Court System has also opened up its parking lots to the public for evening and weekend parking; and

WHEREAS, the Alaska Legislature operates a downtown parking lot containing more than 100 accessible spaces which could also be made available to the public for evening and weekend parking; and

WHEREAS, the Anchorage Assembly previously requested the Legislature to make these spaces available by approving Assembly Resolution 2000-176 on June 18, 2000; and

WHEREAS, public use of the Legislature's parking area on evenings and weekends will encourage further development of downtown Anchorage by making downtown accessible to residents and visitors using private transportation.

NOW, THEREFORE, the Anchorage Municipal Assembly resolves.

<u>Section 1</u>: That the Alaska Legislature is again urged to make its downtown parking lot located at 716 W. 4th Avenue available for public parking on evenings and weekends.

Section 2: That this resolution is effective upon passage and approval.

<u>Section 3</u>. That, upon passage and approval, the Municipal Clerk forward a copy of this resolution to the Alaska Legislature.
