A RESOLUTION TO AMEND THE COLLECTIVE BARGAINING AGREEMENT BETWEEN THE ANCHORAGE POLICE DEPARTMENT EMPLOYEES ASSOCIATION AND THE MUNICIPALITY OF ANCHORAGE REGARDING STEP PLACEMENT UPON PROMOTION TO POLICE SERGEANT.

WHEREAS, the Municipality of Anchorage (hereinafter MOA) and the Anchorage Police Department Employees Association (hereinafter APDEA) recognize that collective bargaining is the preferred method to settle labor disputes; and

WHEREAS, the MOA and the APDEA agree that the current collective bargaining agreement does not address step placement of officers upon promotion to Police Sergeant, and

WHEREAS, the MOA and the APDEA have negotiated new contract language to address step placement upon promotion to Police Sergeant, and

WHEREAS, the APDEA members have ratified the proposed language; and

WHEREAS, Anchorage Municipal Code 3.70.130 requires that the Assembly ratify or reject negotiated labor contracts and amendments in the same manner as municipal ordinances.

NOW, THEREFORE, the Anchorage Assembly hereby approves the new language that amends Article XV of the APDEA collective bargaining agreement addressing step placement upon promotion to Police Sergeant. As set forth in the Assembly Memorandum submitted herewith,
