A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY REQUESTING CONGRESSIONAL FUNDING TO BOTH UPDATE THE KNIK ARM CROSSING CORRIDOR ANALYSIS AND TO FURTHER IMPLEMENT REGIONAL LAND USE AND TRANSPORTATION PLANNING BETWEEN THE MATANUSKA-SUSITNA BOROUGH AND THE MUNICIPALITY OF ANCHORAGE.

WHEREAS, the Matanuska-Susitna Borough and the Municipality of Anchorage are part of one regional economy; and

WHEREAS, the Matanuska-Susitna Borough and the Municipality of Anchorage share an integrated transportation system; and

WHEREAS, the Matanuska-Susitna Borough and the Municipality of Anchorage wish to work closely together on regional transportation, economic development, and land use planning and policy issues; and

WHEREAS, a Knik Arm crossing would bring transportation and economic benefits to all of Alaska and to southcentral Alaska in particular; and

WHEREAS, a substantial investment has already been made to study the costs and benefits of a Knik Arm crossing; and

WHEREAS, the Assemblies of the Matanuska-Susitna Borough and the Municipality of Anchorage believe that it is in the public interest to move forward with stronger regional land use and transportation planning and to update the Knik Arm Crossing analysis.

NOW, THEREFORE, the Anchorage Assembly resolves:

Section 1: That funding is requested from Alaska's congressional delegation to update the 1983 Knik Arm Crossing analysis; and

Section 2: That the update to the Knik Arm Crossing analysis should include regional land use, and a multi-modal transportation analysis and needs assessment for the transportation network shared by the Matanuska-Susitna Borough and the Municipality of Anchorage.
