**New Platted Lots** 

Additional funding is needed to complete the judicial determination of land boundaries, lot corner staking and filing a new plat for the Rabbit Creek Survey Improvement District 1V96 established by AR 97-35. The attached Assembly Resolution appropriates \$310,000 as a loan from the Areawide General Operating Fund (101) to the Cash Pool Balance to pay for surveyor fees and unanticipated legal fees associated with the current litigation of Rabbit Creek Heights Subdivision and Rabbit Creek View Subdivision. Of the \$310,000, \$237,000 is for Contract Amendment 3 to the Professional Services Contract with Kean and Associates, which is submitted for action concurrently with the resolution.

The Anchorage Assembly approved the appropriation of \$350,000 on March 4, 1997 to fund Phase I and II of the Rabbit Creek Survey Improvement District. On June 15, 1999 the Assembly approved Resolution 99-100(S) appropriating \$400,000 to provide funding for Phase III of the re-survey and platting project. This amount was anticipated to cover court exhibit preparation, attorney presentation of the case at trial, final plat preparation, plat filing fees, land title work and re-monumentation of the subdivisions. However, the funding has been exhausted in support of prolonged and unforeseen litigation with Chugach Electric Association (Chugach) and several property owners who objected to the certain components of the new plat. Agreements have been reached with the property owners, but the Municipality remains in disagreement with Chugach.

The Municipality objects to Chugach's election to use the Rabbit Creek Survey Improvement Assessment District court case as a vehicle to gain additional easement rights at the expense of the Assessment District. Chugach has insisted that their implied rights should be dedicated on the plat as part of the court action for plat approval without contributing any funds to the costs associated with that effort, now exceeding \$70,000. The Municipal Attorney has filed a motion and counterclaim against Chugach for costs incurred by the Improvement District to reach agreement on Chugach's easement rights, but Chugach has continued to insist the assessment district property owners bear the costs of the plat benefits Chugach desires, but which are not necessary to the conclusion of the replat.

The costs for the project are to be repaid by the Rabbit Creek Survey Improvement Assessment District to the extent determined by the Assembly following a public
