A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE ACCEPTING AND APPROPRIATING FIVE MILLION EIGHT HUNDRED FIFTY THREE THOUSAND SIX HUNDRED FIFTY EIGHT DOLLARS (\$5,853,658) AS A STATE OF ALASKA LEGISLATIVE GRANT PER SENATE BILL 29 TO THE PORT OF ANCHORAGE CAPITAL IMPROVEMENT PROGRAM FUND (571) AND REVISING THE 2001 PORT OF ANCHORAGE CAPITAL BUDGET FOR THE PORT OF ANCHORAGE INTERMODAL MARINE FACILITY PROJECT

WHEREAS, the 2001 Port of Anchorage Capital Budget contained a Three Million Dollar (\$3,000,000) appropriation for the Port of Anchorage Intermodal Marine Facility (IMF) Project; and

WHEREAS, the 2001-2006 Port of Anchorage Capital Improvement Program anticipated an additional Three Million Dollar (\$3,000,000) appropriation for the IMF Project in 2002; and

WHEREAS, through Senate Bill 29 the 2001 Alaska Legislature appropriated Six Million Dollars (\$6,000,000) to the Department of Transportation and Public Facilities (DOT&PF) for the Port of Anchorage Intermodal Marine Facility Project; and

WHEREAS, the Port of Anchorage and DOT&PF will enter into a Memorandum of Agreement which allows for the transfer of the legislative appropriation to the Port of Anchorage less a required reduction by DOT&PF for its indirect costs, for a net transfer of Five Million Eight Hundred Fifty Three Thousand Six Hundred Fifty Eight Dollars (\$5,853,658); and

WHEREAS, receipt of the subject grant requires a revision to the 2001 Port of Anchorage Capital Budget appropriation approved November 8, 2000 in the amount of \$2,853,658; and

WHEREAS, the Administration and the Assembly have reviewed the grant offered by the State of Alaska; and

WHEREAS, on 9/25/01 a duly advertised public hearing was held in accordance with Section 6.10.085 of the Municipal Code.

NOW, THEREFORE, the Anchorage Assembly hereby resolves:

Section 1. That a State grant in the amount of Five Million Eight Hundred Fifty Three Thousand Six Hundred Fifty Eight Dollars (\$5,853,658) is hereby accepted and appropriated to the Port Capital Fund (571) for the Intermodal Marine Facility Project.

Section 2. That the 2001 Port of Anchorage Capital Budget as adopted on November 8, 2000 is hereby revised as follows:
