MUNICIPALITY OF ANCHORAGE ASSEMBLY RESOLUTION OF THE APPROPRIATING UP TO FIVE HUNDRED TWENTY-TWO THOUSAND, NINE HUNDRED EIGHTY-FOUR DOLLARS (\$522,984) IN THE DEFERRED REVENUE ACCOUNT OF THE HERITAGE LAND BANK GENERAL FUND (221) TO THE AREAWIDE GENERAL CAPITAL IMPROVEMENT FUND (401) FOR THE CHESTER CREEK AQUATIC RESTORATION PROJECT.

WHEREAS, in 1998, the Heritage Land Bank received \$522,984 to assist in the future restoration of Chester Creek; and

WHEREAS, the Assembly approved AO 98-169 on October 12, 1998 to place said funds into the Heritage Land Bank (HLB) Fund (221) as a Special Revenue Fund to be held separately and reserved for compensatory mitigation purposes such as waterways restoration; and

WHEREAS, the Municipality of Anchorage's Project Management and Engineering Department is coordinating a multi-year, \$7,034,000 project called the Chester Creek Aquatic Restoration Project for the design and construction of improvements to the Chester Creek outfall area located at the west end of Westchester Lagoon; and

WHEREAS, a portion of this project is to be funded by money held in the reserve account of the HLB Fund and is considered an appropriate use of these funds;

NOW THEREFORE. THE ANCHORAGE ASSEMBLY HEREBY RESOLVES:

That the sum of up to FIVE HUNDRED TWENTY-TWO THOUSAND, NINE Section 1. HUNDRED EIGHT-FOUR DOLLARS (\$522,984) currently held in the deferred revenue account of the Heritage Land Bank General Fund (221) be appropriated by Project Management and Engineering for the Areawide General Capital Improvement Fund (401) for the Chester Creek Aquatic Restoration Project's Westchester Lagoon outfall reconstruction.

Section 2. The resolution shall take effect immediately upon passage.
