2 A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING ONE
3 MILLION THIRTY THOUSAND DOLLARS (\$1,030,000) OF REVENUES FROM WITHIN THE
4 AREAWIDE GENERAL CAPITAL IMPROVEMENT FUND (401), SIXTY TWO THOUSAND
5 DOLLARS (\$62,000) FROM WITHIN THE ANCHORAGE PARKS AND RECREATION
6 CAPITAL IMPROVEMENT FUND (461), AND ONE HUNDRED TWENTY SIX THOUSAND
7 DOLLARS (\$126,000) WITHIN THE CHUGIAK-EAGLE RIVER PARKS AND RECREATION
8 SERVICE AREA CAPITAL IMPROVEMENT FUND (462) FOR FACILITY IMPROVEMENTS
9 AT THE ALASKA CENTER FOR THE PERFORMING ARTS, WILLIAM A. EGAN CIVIC AND
10 CONVENTION CENTER, GEORGE M. SULLIVAN ARENA, ANCHORAGE GOLF COURSE,
11 BEN BOEKE/DEMPSEY ANDERSON ICE ARENAS, AND THE HARRY J. MCDONALD
12 MEMORIAL CENTER.

13 THE ANCHORAGE ASSEMBLY RESOLVES:

14
15 Section 1. That One Million Thirty Thousand Dollars (\$1,030,000) is appropriated from within
16 the Areawide General Capital Improvement Funds (401) for 2001 improvements to the Alaska
17 Center for the Performing Arts, Egan Civic and Convention Center, Sullivan Arena, and the
18 Anchorage Golf Course.

20 Section 2. That Sixty Two Thousand Dollars (\$62,000) is appropriated from within the
21 Anchorage Parks & Recreation Capital Improvement Fund (461) for 2001 improvements to the
22 Ben Boeke and Dempsey Anderson Ice Arenas.

24 Section 3. That One Hundred Twenty Six Thousand Dollars (\$126,000) is appropriated from
25 within the Chugiak-Eagle River Parks & Recreation Capital Improvement Fund (462) for 2001
26 improvements to the Harry J. McDonald Memorial Center.

28 Section 4. This Resolution shall become effective immediately upon passage and approval
29 by the Anchorage Assembly.
